Dear City Council,

I am writing to add my voice to the growing group of confused Piedmont citizens regarding the lack of action being taken to preserve a pool facility for our community. My family has been swim club members for many years, and although my children are beyond the ages of wanting to spend much of their time at the pool, I enjoy occasional lap swimming and do believe a facility suitable for a variety of uses is needed in Piedmont. With growing alarm I have been following the muddled chain of events that have led us to this point, and I cannot understand the inaction of the city to preserve a much used and needed facility. While the gesture of offering a short-term lease extension to PSC is heartening, it in fact would only create a deeper future financial problem for the swim club and its members as such a short future would not allow for a stable income for the club to maintain its operations and staffing. I urge you to reconsider your position on the term of the lease extension being offered to PSC. By allowing a longer lease extension,

not only will it improve the feasibility of the swim club's finances, but it will also minimize the length of time the community is without a pool facility.

The future of the city center is deserving of careful and thoughtful planning, and I applaud the deliberate and careful approach the Council is taking. Unfortunately, the time this process takes combined with the uncertain use of Measure E funds does not seem to indicate there is imminent action in redeveloping this area. One can only assume there is some agenda yet to be disclosed regarding your plans for the pool facility, and how allowing it to operate in the interim would be counterproductive to your purposes. However, as representatives of the citizens of Piedmont, I believe you have an obligation to serve the best interests of the community. Unless I have completely misunderstood the situation, there is not a single interested group in favor of going without water space for an extended period of time. If you do intend for the City to take over the operations of the pool at the conclusion of its lease, bravo! But as a courtesy to the pool members and the community, disclosing this information would put many minds at ease. If you have no plans, it is past time to make them and you are doing a disservice to the community by ignoring this issue.

We'd like to express our concern about the fate of the Piedmont pool. Given the choices of closing the pool, extending the PSC lease for three years, or having the city operate the pool at a loss of close to a million dollars over three years; the best options appears to be the lease extension.

We've been members of the PSC since we moved to Piedmont six years ago and have nothing but good things to say about the operation of the club. Having the pool walking distance has been a great benefit to our family, year round. The PSC has been a wonderful addition to the community both for parents and kids, and I cannot imagine my kids' summers without a pool close by – for weekends and for camps.

There is no question that the future of the pool will be different than it's current situation, but that future is not close at hand. When Dracena Park was redone, the entire park was closed in June, then they didn't break ground until Fall. The entire summer of play at that park was lost to the children – due to construction delay realities. The same situation faces you with the Piedmont pool. There is no way a new pool will be completed in the next year or two – not with all the other work in the master plan. Make the planned changes to the pool, but until they are ready to break ground, please extend the PSC lease – three years seems reasonable for all parties involved.

Dear Madam Mayor and Members of the Piedmont City Council:

Please consider sympathetically the proposal for a three-year "Transition Extension" of the Piedmont Swim Club's lease, now ending June 30, 2008, until June 30, 2011.

There is widespread Piedmont interest in access to the PSC pool—by the Piedmont high school teams, the Piedmont Swim Team, and other non-paying bodies, as well as by paying members of the PSC. While everyone wants a successful Civic Center Master Plan construction process, keeping water space available as long as possible in the interim—i.e., continuity of water—should be a part of that objective.

The PSC is offering its services at, I believe, no charge to the City. Its offer should not be denied in response to the chimera of "economic blackmail" or "cooked books" that have been bandied about. And the decision on whether the new pool should be municipal rather than quasi-private is better addressed at the time a new pool is built, not with respect to an interim pool during an interim period.

To let the PSC pool lie fallow during the transition period would be poorly received by a large water-inclined constituency. And setting up a municipal-style pool to operate just during the transition period would seem a financial extravagance.

Why not let the PSC continue doing during the transition period what it has been doing so well during the past forty years? A three-year "Transition Extension" is merited and deserves your approval.

I understand that there will be another discussion of the future of the Piedmont Pool lease on December 17. As I've written a few times about this topic, you may recall that I write from the perspective of a Swim Club (but not Board) member, daily lap swimmer, but also as the mother of a PHS water polo captain who is also a Piedmont High School and Piedmont Swim Team swimmer. Not to put too fine a point on it, I'm passionately committed to having a pool in Piedmont. I strongly support the concept of a new pool, but acknowledge the reality that it is at the very least a few years away (perhaps many years away) from reality. My hope is that the current pool management will be afforded the kind of lease conditions that it requests to be able to continue running the existing pool in the interim. Should this not occur, then my earnest desire is that the City keep this pool open and available for Piedmont residents with no hiatus in this operation.

Our pool is a wonderful resource that should not be allowed to wither away because negotiations stall. Already, the Piedmont Swim Club has lost its manager and assistant manager, as well as a significant number of its members due to the protracted nature and uncertain outcome of the on-going negotiations. Please don't let the whole operation "evaporate." My main concern is for my son and his teammates and other Piedmont children who benefit from the use (both PHS and private) of the pool. Should the pool not be available for their use this upcoming year, I believe that would be a death-blow for a very promising and energetic water polo team and would severely impact the swim team programs, both private and school-related. # Dear City Council Members:

My family has been a member of the PSC for the last nine years, my husband's family (Fennell) were founding members of PSC over 40 years ago. We are active users of the pool (5+ times a week) as swim team members (Kelsey & Marina Fennell) and as lap swimmers. I strongly support the development of a new expanded aquatic facility within Piedmont as we get squeezed on both sides of our pool usage and understand personally the lack of adequate water space in the City.

Having said that, I also know how long it takes to work through all the civic issues of funding, plan development and approval and governmental regulations that go into such an effort. If we use the Haven's retrofitting as a benchmark in how such a progress goes, (we're in portables for a second year this year with not one shovel dug for new construction) in a best case scenario, I would expect it will take at least three years before the city is ready to start construction on this new facility. In the meantime please let the PSC continue to operate the pool for the benefit of the members and community. The staff and management do an excellent job of accommodating, with in the constraints the facility affords them, the needs of the members and the swim team, and at no cost to the city. Why would the city want to be in the business of running the pool for the next three years if it doesn't have to and the PSC has proven with it's 40+ years of being a very competently run facility? Let's take that \$327K a year the Sports Mgmt Report projected (almost a million over three years) and put it toward the new facilities.

I urge you to accept the final lease proposal put before the board. It allows swimming to continue in Piedmont with no out of pocket expense to the city and it provides the PSC some avenues to recoup some of the financial decline it's suffered over the last three years by providing them fair rent credits up to the true value of what they provide the city and it's agencies (school mates, rec department, school district) and allows them to charge the Piedmont Swim Team, an independent organization, a fair and reasonable rental fee that they would have to pay elsewhere. And perhaps on a selfish note, it allows my kids to walk to swim practice from schools and me to ride my bike to the pool for lap swimming. The closure of our facility would force us to go outside the our community to continue our swim activities.

Please support this final proposal by endorsing and then voting in favor of the proposal submitted by the PSC Board.

## Ladies and Gentlemen:

The Piedmont Swim Club board offers up a false choice of only 3 possible scenarios for the future of the pool, leading to the conclusion that renewing the lease is the only viable solution. There is another.

Let the lease expire on schedule this July. The pool continues to operate. The current aquatics director or a replacement hired by the Recreation Department continues to manage the pool. An Aquatics Commission with representatives from all stakeholders decides on scheduling of its user groups. Current club members and any other interested Piedmonters continue to support the pool financially with an appeal for annual, seasonal, monthly and daily subscriptions.

In a previous letter to the Council I outlined suggestions for improvement in the management of the facility. Streamlining staff, improving personnel management, and discontinuing outsourcing for janitorial helps in the expense column. Expanding lessons, events, and product sales helps in the income column.

The Sports Management Report, dated October 2006, was found to have numerous false expense assumptions, such as inflated insurance costs, and was found to ignore the income opportunity of community subscriptions, which Piedmonters are likely to support.

Ending the lease this July and allowing the city to "get its feet wet" with the current pool is a transition plan that makes sense as we look to the future of a new aquatics center and the Civic Center Master Plan.
